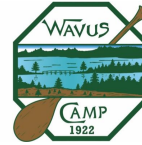

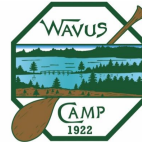
How to Request Financial Aid When Applying to Camp

The following steps must be completed to be enrolled in camp with financial aid. KWE will respond to financial aid requests on a rolling basis, first-come, first-serve.

1. Complete the Financial Aid Request form.
2. Share the first two pages of last year's Income Tax Return Form 1040 by uploading in the Financial Aid Request form at kwe.org or emailing or mailing it to Nadine Hallisy for Kieve and Joy Bengtson Giffen for Wavus.
3. Apply to camp via kwe.org. Be sure to indicate in section five of the application that you will be requesting financial aid. Families applying for financial aid will not be charged any deposit or tuition fees upon enrollment without prior approval.
4. If you receive and accept your financial aid package, you will be notified of enrollment.
5. Once enrolled, we will direct you to more information on how to prepare for your camper's exciting summer ahead.

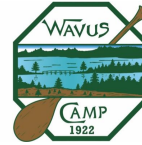
